Your Dollars at Work

Because of your generosity, we were able to purchase specialized equipment such as:



Children's Transport Truck

The children's transport trucks are built to be an extension of the Intensive Care Units (PICU/NICU) to keep critically sick or injured patients stable until arriving at the hospital. Over 1,200 pediatric patients have been transported this past year. That's over three patients requiring intensive level transport every day. Just like Maynard Children's Hospital, this specialized ambulance has an under the sea theme to ease children's fears and anxieties during their ride.



Diono Car Seats

Getting around can be challenging after undergoing hip or leg surgery. Certain car seats are not equipped to fit and maintain support for children with special casts and braces. This car seat is designed to make a patient's ride safer and more comfortable during their ride home and to appointments.



Panda Warmers

A Panda Warmer is a critical piece of equipment for ensuring the safe transition of newborns immediately after birth. It provides a controlled, thermally stable environment that supports both routine post-delivery as well as emergency resuscitation when needed. Approximately 15% of births at Maynard Children's Hospital every year require unexpected interventions. In these critical moments, access to these warmers is essential in stabilizing and supporting neonatal outcomes.
